## Crime Scene Technicians (CSTs) work on a hourly basis

- Any additional hours outside your normal scheduled time are considered overtime
  - CSTs work 10 hour shifts
    - 1st Shift (7:30 am 5:30 pm)
    - 2nd Shift (5:00 pm 3:00 am)
    - 3rd Shift (10:00 pm 8:00 am)
  - There are two Latent Print Examiners who are also assigned to this unit; this is a promotional position that works during the day (in four 10 hour shifts)

#### Overtime

- Recorded as time and a half
- Can be taken as pay or comp time
- Available opportunities for overtime

## **Training**

- Numerous opportunities for additional training
- 12 week field training program
  - 4 weeks with each shift
  - Probation is one year
- Various refresher and new courses offered throughout year

#### Vacation Time
